

Schedule of Harbour Dues 2010/11 (amended)

Under the Harbours Act 1964 & The Hayle Harbour Act 1989.

All vessels entering the jurisdiction of the harbour must pay dues as set out below. All dues are exclusive of vat.

1.1 Mooring licence :- all vessels £10

Harbour Dues at Hayle: -

2.1 Pleasure vessels not engaged in trade and all vessels in lay up at Lelant Saltings.: - Period 1st April 2010 – 31st March 2011. No part payment possible.

<6m £19.80 per metre
>6m < 8m £22.40 per metre
>8m < 10m £23.90 per metre
>10m £27.80 per metre

2.2 Registered Commercial and Registered Fishing Vessels: This will be paid in two instalments payable on the 1st April & 1st October. No part payment possible.

<8m £38.22 per metre >8m <10m £45.15 >10m £47.20

2.3 <u>Visiting Registered Commercial and Registered Fishing vessels short term dues</u>

2.4 Dues for visiting pleasure vessels not engaged in trade:

2.5 Dues for Sheltering Local Vessels by arrangement with the Harbour Master

All Visiting and Sheltering Vessels should give at least 1 days notice to the Harbour Office. Vessels over 20m OAL must give 7 days notice before entering Hayle Harbour.

Moorings on Penpol Terrace: -£17.00 +VAT per vessel is charged by the Duchy of Cornwall, which is in addition to the Harbour dues for the period 1st April 2010 – 31st March 2011. No part payment possible.

Visitor Slipway Launching: - £10.13 per day, including retrieval + VAT

Season Slipway tickets are available upon request.

<u>Dry Berthing</u>: - £40.00 + VAT per calendar month payable in advance up to 6 m. Rates above 6 m available on application. No part payment possible. All dry berthing will be under Licence, to be signed before berthing commences. Dry Berthing will be allocated by the Harbour Master.

Car Parking on Foundry quay

A non returnable charge of £10 + VAT will be payable for a swipe card and parking permit.

Mooring Waiting List

A non returnable charge of £17.02 + VAT will be payable for those wishing to go in the waiting list.

8 Harbour Dues

It is the responsibility of the owner or skipper of any vessel brought within the jurisdiction of Hayle Harbour to pay appropriate harbour dues.

Harbour dues will be charged at the daily rate for every day a vessel is in the harbour, unless arrangements are made with the Harbour Office to pay on an annual, monthly or weekly basis.

Failure to pay Harbour dues may result in vessels being impounded until all outstanding dues have been paid.

Hayle Harbour Act Part IV Paragraph 43 states "If the owner of any vessel shall at any time evade, or attempt to evade, payment of any charges payable by such owner to the Company at the time when the same shall become due and payable, he shall be liable to pay to the Company a sum of £20 or a sum equal to three times the amount of such charges (whichever shall be the greater), which sum shall be a debt due to the Company."
