3.	Marine Minerals Ltd Presentation	
	MML gave a presentation on their plans to extract tin from sea floor sand along	
	a 34km stretch of the north coast about 1km off shore. The extraction would	
	not exceed a depth of 2.5m and over 95% of the sand extracted would be	
	returned after on-vessel processing. This is a suction process and does not	
	involve dredging. They are still in the design phase and have secured the	
	services of consultants to ensure they comply with all regulations. An	
	announcement will be made in a few weeks and, until then, they request that	
	their presentation remains in confidence.	
	The HHAC members engaged in an extended Q&A session, although some	
	questions could not be answered until engineering and scientific issues were	
	firmed up.	
4.	Approval of Minutes of 11 July 2012 and Matters Arising	
	The chairman reported that the actions attributed to him had been carried out.

5.	Hayle Harbour Authority Ltd Harbour Master's Report	
	HM Peter Haddock presented his report and took questions and comments.	
	These included:	
	<ul> <li>Outstanding issues with the new fishermen's landing area, some of</li> </ul>	
	which were in hand (dredging of North Quay to improve access, chains	
	on the davits). The HM agreed to meet with the fishermen separately to	
	discuss issues that were not appropriate for the HHAC including turning	
	areas for lorries and areas to be fenced.	
	The issue of tombstoning was discussed and the police reported on	
	success with identifying some individuals. An issue of dangerous activity	
	in the water near the Carnsew sluice is also under investigation.	
	The HM reported that current regulations permit maintenance dredging	
	without a permit provided certain constraints were met (which include	
	some before and after testing).	
	It was noted that the internal audit of the SMS had been carried out and	
	that the Designated Person, Mark Capon, would be timing his inspection	
	to coincide with the next HHAC meeting and would report on this.

(b) Simon Clarke advised that he had commissioned some studies on material costs on options for the Penpol Terrace bridge. Once he had these he would proceed with the public consultation as to the location of the bridge. This is expected to take place within a couple of months.  (c) There were no further updates on the issue of harbour governance which had been discussed at the last HHAC meeting.	
7.	Hayle Estuary Management Plan	
	The chairman advised that the HEMP had been updated to reflect the new list of fish provided by Peter Ghey at the last meeting. He had also made a few editorial corrections.  In discussing how best to proceed with implementing HEMP actions it was felt that this is difficult until an Estuary Officer can be appointed. The possibility of the Hayle Harbour Trust's CCF project providing some funding was discussed.	
8.	Any other business	
	<ul> <li>The police reported that there had been a significant drop in harbour crime over recent months although reports of increased harbour crime in Falmouth and St. Austell had been reported. It appears to be mobile gangs. PC Trevorrow undertook to continue vigilance at the harbour which is still a Town Council priority area.</li> <li>The chairman reported that English Heritage had just given Scheduled Ancient Monument status to the whole of the Millpond complex and to the Plantation on both sides of the railway line. This had been commenced in 2001 and was unexpected but welcomed.</li> </ul>
